AzIDA does not complete any preclosing review or approval on HOME+PLUS transactions.

Each approved participating lender is delegated to conduct all HOME+PLUS program compliance as well as adhere to all Agency/GSE and mater servicer rules, regulations, and guidelines.

Underwriter Certification


- The UW Certification is an embedded doc in the reservation system that must be downloaded, completed, signed, uploaded back in the system, and then electronically submitted.
- The underwriter certification process is intended to have the lender "put a second set of eyes" on the transaction, reviewing for accuracy before generating the HOME+PLUS closing documents.




UW Certification

To generate the Underwriter's Certification form

• Click the "PDF Docs" icon for the respective loan.



• Click the box next to the Underwriter's Certification.



Then click the "Generate Documents" button.



UW Certification – important items to review:

- 1. Has the Pre purchase homebuyer education been completed through a HOME+PLUS approved provider?
- 2. Is the borrower(s) annual income BELOW the specific program income limits?
- 3. Does the final first mortgage amount in your operating system match the final first mortgage amount in the HOME+PLUS Lender-Online reservation?
- 4. On a convention transaction does the AUS match the reserved mortgage type?
 - FNMA HFA Preferred = DU
 - FHLMC HFA Advantage = LPA

Many of the fields in the reservation cannot be edited by the lender. If changes are necessary, please contact the HTS Team at:



 System updates are processed in 30 minutes or less.




- Once the Underwriter Certification has been completed, make sure it is signed and dated, and then save to your PC.
- Within the HOME+PLUS Lender-Online reservation system, click the "eDocs" icon on the respective transaction.



Click on the "Add New" icon from the Executed Underwriter's Certification Box.






• Select "Executed Underwriter's Certification" from the dropdown list. If needed, ad any notes or comments.



• Select the "Click Here" button and a "Get File" box will pop-up.




• Click the "Choose File" box, select Browse, search for the Underwriter's Certification document saved on your PC, and then click "Upload".






• After the UW Certification has been uploaded select the "save" icon and you will receive the Update Successful notification pop-up



•you're not done yet!



• Once the UW Cert has been uploaded and saved, you MUST click the "submit" icon. The system assumes you have more documents to upload until you "tell it" you are done.



- When done correctly the Initial Submitted Date & Time field will be populated.
 - Within 3 minutes, the loan status will update from Reserved to Certification
 - All HOME+PLUS closings documents will now be available under the PDF Docs icon.
