The process of uploading documents into the HOME+PLUS Lender-Online system is the same whether you are uploading:

(1) Pre-closing Review Package – Arizona Is Home
 (2) Underwriter's Certification – HOME Plus
 (3) Post-Closing DPA Compliance Package – either program
 (4) Trailing Conditions or Stips – either program



The pre-closing review replaces the "Underwriter Certification" step that the lenders are familiar with under the HOME Plus DPA program.

Hilltop Securities (HTS) for the benefit of the Arizona IDA will conduct a pre-closing review for all Arizona Is Home transactions.

This step must be completed and an HTS approval granted before closing documents can be access by the lender.

- All Arizona Is Home transactions require a pre-closing compliance review by Hilltop Securities (HTS).
- Review and approval by HTS is required before all the embedded closing documents within the Emphasys Lender Online system are made available.

**Documents required for Pre-Closing File Review:** 

- 1. Pre-close Checklist
- 2. Final AUS
- 3. Credit report OR Fraud Report OR VOR
- 4. About Recapture Tax Document
- 5. 92900-LT or 1008
- 6. Initial 1<sup>st</sup> lien URLA
- 7. Purchase Contract
- 8. Arizona IDA Income Worksheet
- 9. Homebuyer Education Certificate
- 10. Extension Request (if applicable)



#### Arizona Is Home Pre-closing Review

This power point focuses on the upload procedures for a preclosing Arizona Is Home package. (some screen shots will reference post-closing compliance package – the process is the same for both) Once all the items on the pre-closing checklist have been stacked and saved on your PC, select the "eDocs" icon from the Loan Status tab for the respective transaction.



• Click on the "Add New" icon from the Pre-Closing Compliance Pkg Box



The process to upload the post-closing DPA compliance package (as well as the Underwriter's Certification for the HOME Plus program) follows the same process.



# You can upload each document individually or the full Pre-Closing file in one upload.

Click the "Choose File" box, select Browse, search for the Post-Closing Package document saved on your PC, and then click "Upload".



After the Pre-closing compliance package has been uploaded select the "save" icon and you will receive the Update Successful notification pop-up

Once the Pre-Closing package has been uploaded and saved, you MUST click the "submit" icon. The system assumes you have more documents to upload until you "*tell it*" you are done.

When done correctly, the Initial Submitted Date & Time field will be populated.

Be sure to check back into the transaction within 48 hours to view any potential conditions or stips.

Current turn around time on Pre-closing compliance packages is 48 hours.

Once the lender successfully uploads the Arizona Is Home Pre-closing compliance package into the Lender-Online system, it is the lenders responsibility to log into the system and follow up on the transaction for any updates, pend notices, etc.

The lender can view the status of the file by selecting the "View" icon from the Loan Status tab



Any outstanding condition for pre-closing review approval will be detail in the HFA's Conditions / Exceptions section.





When the Pre-closing compliance review is complete and the transaction receives the approved / clear to close from HTS, the "stage" status will reflect "Commitment".

At this time, all the closing documents will be available for the lender to generate.

While the Arizona Is Home program has different closing documents than the HOME Plus program, the process and procedures to create the respective documents are the same.
